Updates & prayer points:

PRAY FOR AMERICA'S MILITARY:

U.S. military personnel continue to augment U.S. Customs and Border Protection efforts at the nation's southern border as the U.S. Northern Command works with the Department of Homeland Security. The *USS Gravelly* was deployed to the Gulf of America this month as part of the response to President Trump's executive order that declared an emergency at the border.

Pray for U.S. defense officials and contractors as they seek to maintain the military supply chain.

PRAY FOR AN END TO THE WAR IN UKRAINE:

This week delegations from Ukraine and Russia agreed to a ceasefire in the Black Sea. The agreement to "ensure safe navigation, eliminate the use of force, and prevent the use of commercial vessels for military purposes" came out of talks in Jeddah, Saudi Arabia

Pray for President Trump and U.S. negotiators as they continue to work for peace between Russia and Ukraine.

PRAY FOR AMERICA'S RELATIONSHIP WITH ISRAEL:

The House of Representatives passed a resolution this week that would penalize the International Criminal Court (ICC) for considering charges of war crimes against the Israeli prime minister and defense minister. Despite efforts to make the legislation bipartisan, the White House announced opposition to sanctions for the ICC.

Pray for the president, his foreign advisors, and the House speaker to be discerning as they consider

EXECUTIVE BRANCH: PRAY FOR THE PRESIDENT AND HIS ADMINISTRATION

Pray for the attorney general and Justice Department officials as they seek to defend President Trump's orders and policies in federal courts.

LEGISLATIVE BRANCH: PRAY FOR SENATORS AND REPRESENTATIVES IN CONGRESS

Pray for legislators in both houses of Congress to be discerning as they seek to safeguard veterans' gun rights.

JUDICIAL BRANCH: PRAY FOR SUPREME COURT JUSTICES AND FEDERAL JUDGES

Pray for district court judges as they hear and rule on cases to uphold the law and the U.S. Constitution.

最新情況和祈禱事項：

為美國軍隊祈禱：

在美國北方司令部與國土安全部合作的同時，美國軍方人員持續增強美國海關和邊境保護局在美國南部邊境的行動力度。作為對川普總統宣布邊境進入緊急狀態的行政命令的回應，格雷夫利號驅逐艦本月被部署至美國灣。

為美國國防官員和承包商祈禱，因為他們尋求維持軍事供應鏈。

祈禱烏克蘭戰爭結束：

本週，烏克蘭和俄羅斯代表團同意黑海停火。該協議旨在“確保航行安全，消除使用武力，防止將商船用於軍事目的”，是在沙烏地阿拉伯吉達舉行的會談中達成的。

為川普總統和美國談判代表祈禱，希望他們繼續為俄羅斯和烏克蘭之間的和平而努力。

為美國與以色列的關係禱告：

眾議院本週通過一項決議，將對國際刑事法院 (ICC) 審理針對以色列總理和國防部長的戰爭罪指控進行懲罰。儘管兩黨努力使該法案一致通過，但白宮還是宣布反對對國際刑事法院進行製裁。
